Catholic Charities Diocese of Palm Beach, Inc. is a charitable organization registered in the state of Florida and operating under section 501(c)(3) of the Internal Revenue Code. Our financial statements are audited by the independent CPA firm CliftonLarsonAllen, LLP, which issued an unqualified "clean" opinion for the fiscal year June 30, 2018. Net assets increased \$388,394 in the fiscal year ended June 30, 2018. Expenses for the fiscal year increased as a result of expanding programs. The Disaster Recovery program expanded to meet the needs of the community after Hurricane Irma and a Respite Care program was started to provide relief for caregivers in St. Lucie County. Administrative and fundraising costs were 13% of total expenses. We are grateful to all of our donors for their continued support as we care for the most vulnerable in our society. Our independent audit and IRS form 990 tax return are available for public inspection.

ANTI-HUMAN TRAFFICKING

Taking on a new task can be both exciting and daunting. Ask Catholic Charities' Anti-Human Trafficking Program Administrator, Christina Silvestri, what it has been like bringing this national tragedy into the spotlight in Palm Beach County. Two years ago, Christina took on the role of emotional supporter, care coordinator, advocate, trainer, appointment scheduler and 24-hour, 7-day-per week first responder for the survivors of human trafficking. In just two-years, Catholic Charities has established itself as the leader of anti-human trafficking services in Palm Beach County.


The program has grown to a staff of three, including two case managers, who work tirelessly to provide a victim-centered approach of delivering aid to clients while maintaining its mission of compassion, integrity, and empathy in the service and treatment of human beings.

Joining forces with other agencies throughout the state and with the assistance of the Palm Beach County Sheriff's Office, the Anti-Human Trafficking Program served 35 clients in the last fiscal year. Serving a client in this program requires first gaining the trust of the survivor. They may make contact with the program or case manager several times before actually committing to breaking away from their captor. The escape plan for those trafficked requires a high level of coordination among a huge network of providers. Once away from their traffickers, the individual has an intense level of emotional, financial and mental needs, relying almost solely on Catholic Charities.

Catholic Charities Anti-Human Trafficking Program offers comprehensive case management and direct assistance to all victims of human trafficking, which include minors, adults, and both domestic and foreign-born individuals.

DISASTER RECOVERY

In the fiscal year 2017-2018, the Disaster Recovery Program quickly grew to become Catholic Charities' largest program. This unexpected growth can be attributed to the unforeseen natural disasters in our 5 county Diocese. The team branched out quickly to get immediate aid to those worst hit by the hurricane, but their commitment did not stop there. One year after Hurricane Irma, they continue to assist victims daily.

Families received assistance with replacing Habitat Restore, and St. Vincent de Paul (\$8,828) The Disaster Recovery Program served 2,323 individuals/740 households in fiscal year 2017-18. Approximately 74% of the individuals served (1522 individuals/546 households) attended our 7 outreach events immediately following Hurricane Irma in September and October. The events were scheduled during late afternoon or evening hours. At these events, needs assessments were completed on all families, attendees were assisted with the completion of FEMA applications, and all were provided food packages and/or gift cards.

After initial hurricane relief in the form of our outreach events in September and October, the program began assisting low income clients with rent or utility assistance due to hurricane related financial hardship. Throughout the two month period of assisting with hurricane related financial hardship, the program began looking at how they could assist with home repair cases, most of which were in the appeal process with FEMA.

From January to June, the program worked on vetting the home repair cases, once denied by FEMA. This included gathering proof of ownership, getting estimates for home repair, and vetting construction vendors. Actual work on program funded home repairs began in the current fiscal year (Sept. 2018). Multiple home repairs have been completed including a new roof and ceiling repairs.

PROGRAMS & MINISTRIES



BIRTHLINE/LIFELINE

Catholic Charities' Birthline/Lifeline Pregnancy Care Program served 2,767 unduplicated clients in fiscal year 2017-2018, of those, 736 were new clients. The program provided 9,511 units of service as well. Birthline/ Lifeline continued to grow the Nursing Moms Group, which meets weekly to offer breastfeeding support and information in a relaxed, supportive group setting. Clients have enjoyed this support and found it very helpful. One client came to the group almost having given up with breastfeeding her newborn because she was continuing to have difficulties. With the support of the volunteer lactation consultant who leads the group and peer support from other clients in the group, this client was able to overcome the difficulties she was experiencing and went on to continue to nurse her baby beyond one year old.

More than 40 women came to Birthline/Lifeline undecided or abortionminded and decided to parent or make an adoption plan after meeting with a client advocate and having an ultrasound. Birthline/Lifeline began to work more closely with Catholic Charities' Project Rachel to refer clients who suffer the consequences of past abortions, so that they are able to receive healing and support. Clients are overwhelmingly happy with the services they receive; commenting that staff understand their concerns, are knowledgeable, and are compassionate.

COUNSELING

The Catholic Charities Counseling Program provides mental health services to individuals (adult and children) and families who would not otherwise be able to afford counseling services. This year the Counseling program served 435 unduplicated clients and provided 3,289 counseling sessions. The program also hired two new counselors and began expanding into group counseling services and community psychoeducational groups. This includes parenting class for parents at the Samaritan Center for Boys and Families, summer group sessions for youth in Pahokee and group sessions at Mary's Shelter. Finally, the program organized its first 5k Glow Run Fundraiser to support the counseling program and promote mental health and wellness.

ELDER AFFAIRS

358 clients/families received direct service, advocacy or guidance to better plan for their long-term care and financial needs in fiscal year 2017-2018 thanks to the Elder Affairs Program. 772 home visits were made to 92 clients in their residential home settings including private residence, nursing home, assisted living and supportive group homes. Case managers visited clients to ensure they were appropriately cared for in their settings and receiving services to ensure their safety, medical, spiritual, social and personal care needs were being met; four of those clients were determined to require a higher level of care and were placed in appropriate care settings to meet their needs and eight of those clients now receive entitlements/benefits such as Medicaid, VA and long-term care benefits to help offset the cost of long-term care they may not have been to afford otherwise.

HUNGER, HOMELESS AND OUTREACH

The Hunger, Homeless and Outreach Program made 239 disbursements to 215 unduplicated households during the 2017-2018 fiscal year. The program provided \$192,268 in direct financial assistance for rent, utilities and other miscellaneous expenses to the 215 unduplicated households. 88.72% of households contacted after receiving financial assistance remained stably housed or had their utility service preserved after 12 months.

IMMIGRATION LEGAL SERVICES

Grant work with Palm Beach County Victim Services continues, law enforcement are assisted with filing for immigration status.

INTERFAITH HEALTH AND WELLNESS PROGRAM

The Interfaith Health and Wellness Annual Awards Luncheon, held in April, raised \$19,155 for the ministry (the most successful YTD). The Interfaith Health and Wellness Ministry has held 18 health education workshops and blood pressure screenings, distributed hygiene kits to the homeless, and connected the uninsured to free community health clinics. Weekly educational workshops included Healthy Nutrition and Life Skills where participants received nutritious meals, fruits/vegetables, and healthy meal planning instruction. Eight new nurses completed the Faith Community Nursing course and 22 attended the Alumni Dinner. Monthly Parish Nurse meetings have been held covering topics such as: Alzheimer's care and caring transitions, advance directives, prescription discount programs, and respite and special needs resources.

SUCCESS STORIES:

A middle-aged women needed a medical exam in order to get employment but she had no income and had depleted all of her savings. The mobile medical unit outreach in Riviera Beach provided her a free physical exam. She said, "I'll no longer be homeless because I'll have a job again and now know where to go for help."

"My quality of life has improved since learning from the nurse how to access services within the community and how to take care of my health." The nurse provided a free blood pressure screening and explained the importance of taking prescriptions as prescribed, avoiding high salt and high fat foods, and how to manage his chronic

PARISH SOCIAL MINISTIRES

In the last fiscal year, Catholic Charities Parish Social Ministry awarded 24 local CRS Rice Bowl grants. Besides parish food pantries, grantees included an ethical trade start up, a reduced lunch program at a Catholic school, a program empowering low income women, and nutrition education programs. During Lent, 47 parishes, schools and ministries participated in the CRS Rice Bowl.



PRISON MINISTRY

The Office of Prison Ministry for 2017 - 2018 was managed by Deacon Gregory C. Quinn. The ministry provides Sacraments, RCIA, Bible Studies and counseling for adults and juveniles in nine state-run correctional facilities and eight county-run jails within the Diocese of Palm Beach. On average 467 people are served every week by 138 dedicated prison ministry volunteers. Their efforts amount to nearly 20,000 volunteer hours annually.

PROJECT RACHEL

The Catholic Charities Project Rachel Program provides counseling and support services to individuals who have been impacted by abortion and/ or miscarriage. This year the program served 6 individuals and provided 22 counseling sessions. The program also established support group services for the community and maintains office hours at the Birthline/Lifeline program. The program also organized a remembrance event for those that have lost a child to miscarriage or abortion.

REFUGEE RESETTLEMENT

The Refugee Resettlement Program has adapted a wider range of specialized service to enable victims to rebuild their lives. The main goal is to provide a safe harbor to the most vulnerable, to integrate newcomers successfully, and to create and maintain thriving, diverse communities that are a model for the rest of the world. During fiscal year 2017-2018, the programs served a total of 135 unduplicated clients and made 1,758 service contacts.

RESPECT LIFE

In late January, The Respect Life Ministry participated in Catholic Days at the Capitol to advocate for laws to protect and defend human life. The Respect Life Office also offered presentations and materials on, "Theology of the Body," to diocesan organizations including schools. Respect Life participated in 40 Days for Life with Bishop Gerald M. Barbarito at local abortion clinics where they prayed the rosary peacefully and prayed for the unborn.

RESPITE SERVICES

The Respite Service program came to life in October 2017. The idea behind this program is to provide services to caregivers of the sick, elderly and homebound of St. Lucie County. Respite care involves short-term or companionship care a few hours per week in the caregiver's home. Clients are very appreciative of "rest" offered through respite services.

SAMARITAN CENTER

Since opening our doors in 1992, The Samaritan Center has served more than 650 families and helped more than 1,700 individuals travel the road back from homelessness. Last year, we served 74 clients by providing 1,914 units of service through life development skills training in parenting, budgeting, and education. The programs primary goal is to promote and develop healthy family values and structure leading to successful re-entry into mainstream society preventing homelessness.
