

## Feature Program Event: Counseling Christmas Tea

The Catholic Charities Counseling Program has brought healing to those in need since 1985. The counseling program provides therapy for adults, children, families, couples and groups in eight locations throughout four counties. Counselors help clients to deal with problems such as depression, loneliness, grief and loss, anxiety, stressful relationships, child and adolescent problems, and other life stressors. On average, the program assists more than 1,300 unduplicated clients annually.

Catholic Charities Counseling Program offers its services to clients on a sliding scale which allows low-to-middle class people to benefit from the therapy services. Still, some clients are unable to afford even these minimal fees and the program constantly seeks grants and private funding to ensure that no client is turned away from services.

Each year the Counseling Program organizes a Christmas Tea in Palm Beach County to raise awareness and funds to support the program. Last year the tea was held at the Norton Museum of Art in West Palm Beach and was attended by more than 90 ladies who enjoyed a Christmas themed Silent Auction and Christmas Carols sung by grade-schoolers from Sacred Heart Catholic School in Lake Worth. More than \$12,000 was raised to benefit the program. These funds will ensure that Catholic Charities continues to be able to serve clients through the Counseling Program regardless of their ability to pay a fee. This year the Counseling Christmas Tea will be held again at the Norton Museum of Art on Tuesday, December 10, 2013.

## Linking up with the Glades Catholic Charities St. Mary's Center in Pahokee

Catholic Charities opened its doors at St. Mary's Center in September, 2012. The center is located on the St. Mary's Parish grounds and houses five Catholic Charities programs.

The location of St. Mary's Center in Pahokee is ideal as it allows the programs to provide much-needed services to all those in need living around Lake Okeechobee from Belle Glade up to Okeechobee. The following services are currently available to the community at the center: *Hunger, Homeless and Outreach; Immigration Legal Services; Interfaith Health and Wellness; Family Counseling; and Birthline/Lifeline Pregnancy Care Center.* 

Catholic Charities has maintained a strong presence in the Glades community for over a decade. The agency's after-school care program originally expanded to this mostly migrant community and operated out of Belle Glade and Pahokee. This past year, after a careful, in-depth program analysis was conducted, the Pahokee Pals After-School Program closed following the summer camp program.

Because Catholic Charities' mission is to the poorest and most vulnerable, it was decided to maintain and strengthen our social service outreach in the Pahokee area. After consultation with local leaders and other community social service agencies regarding services that are needed or insufficiently represented in Pahokee, Catholic Charities expanded existing programs to the Pahokee location.

Three programs immediately began offering services in September 2012 and the remaining two were implemented after funding was secured. The St. Mary's Center is now in full operation and all are invited to visit and tour our new location.



## PROGRAM AND MINISTRY DIRECTORY

#### BIRTHLINE/LIFELINE PREGNANCY CARE CENTERS

"Loneliness and the feeling of being unwanted is the most terrible poverty." - Mother Theresa

Where - Delray Beach, Pahokee, Riviera Beach

**Description** — Women coping with an unplanned pregnancy can access compassionate counseling regarding adoption and alternatives to pregnancy terminations. Proof of Pregnancy is provided for prenatal care referrals. Referrals are made for medical coverage, prenatal care, housing, and emergency assistance. Limited ultrasound is provided by medical professionals. Free material assistance may include maternity clothes, baby apparel and layettes. When available, car seats, strollers, cribs, baby food, formula and diapers are provided.

Case Story – A call came during the late evening via one of our long-time "veteran" hotline volunteers. The hotline volunteer counselor reported that the caller was abortion minded and after two hours of conversation, the counselor was able to encourage this young woman to visit a Birthline/Lifeline Center. During the visit the client shared her life story: She had started contraception at a young age, conceived and aborted her baby.

At Birthline/Lifeline she took a pregnancy test and learned that she was pregnant. Finding herself in the same situation as before, she believed that having an abortion was her best option. An ultrasound offered at the first visit was "too early" for her to actually view the baby. She gave permission for our staff to follow up with her via phone calls. She was also given referrals to a pro-life OB M.D. for prenatal care, Rachel's Vineyard, Legal Aid and Child Support, as well as adoption counseling.

She kept her appointment for a repeat ultrasound and expressed her happiness and gratitude that she had support and assistance from the Birthline/Lifeline staff. She related that she is new to the area and felt alone and far away from her family and faith. She has continued to use the 24 hour hotline service for conversation and is grateful for this communication that is readily available to dispel the loneliness and offer love and support in preparation of her baby's birth day.

#### **CATHOLIC RELIEF SERVICES**

#### Easing Suffering and Providing Assistance Around the World

Where - Diocese of Palm Beach

**Description** - The mission of CRS is to assist impoverished and disadvantaged people overseas, to promote the sacredness of human life and the dignity of the human person. Although this mission is rooted in the Catholic faith, its operations serve people based solely on need, regardless of their race, religion, or ethnicity. Within the United States, CRS engages Catholics to live their faith in solidarity with the poor and suffering of the world and in uprooting the unjust structures that perpetuate poverty, conflict and inequality. Within the Diocese of Palm Beach CRS collects funds through its Operation Rice Bowl and 25% of the donations are used for local outreach.

Case Story - Karen's Kitchen, a volunteer-operated ministry at St. Lucie Parish, opened its doors just a few years ago and today they consistently feed about 250-275 individuals every Thursday. At this soup kitchen the hot, nutritious and tasty meals are served restaurant-style. This year, Karen's Kitchen was awarded an Operation Rice Bowl Grant and the funds received were used to purchase food products to help feed their clients. Clients get a well-balanced hot meal every week as well as bread and canned goods, when available, to take home with them. Fifty percent of those people served by Karen's Kitchen are under the age of 18 years and all are welcome, regardless of age, race, gender, or religion.

Other food pantries/soup kitchens that received CRS grants in 2012: Food pantry at Holy Name of Jesus, West Palm Beach and Matthew 25:35 Ministry at St. Martin de Porres, Jensen Beach.

#### **COUNSELING SERVICES**

#### **Dedicated to All of Our Brothers and Sisters**

**Where** – Boca Raton, Fort Pierce, Pahokee, Palm Beach, Port St. Lucie, Riviera Beach, Stuart, Vero Beach

**Description** - Provides professional counseling in eight locations in four counties to adults, children, families, couples and groups. Catholic Charities' team of therapists address issues such as marital/relationship discord, child and family dynamics, depression, anxiety, divorce, and grief and loss.

**Case Story** — "Fernando" came to the Catholic Charities Counseling office in February as a victim of a crime. Fernando sought counseling due to feeling panicky and anxious after being attacked with a weapon in a hallway at his high school. Fernando felt that he had to watch his back at all times while at school.

Fernando reported that he was cooperating with the authorities and the District Attorney's Office to stop his attackers from hurting anyone else. Before the

incident happened, Fernando stated, "I was a normal 17-year-old boy who loved playing soccer, hanging out with friends and going to school. Since this incident, I am fearful. I do not want to go out anywhere nor take the bus to school. When I do go out, I want to have an adult or a family member with me at all times. I am not taking any chances of something like this happening to me again."

In sessions, Fernando received support and learned coping skills to decrease his anxiety. He learned ways to protect himself by having a companion stay with him, keeping close to the teachers during lunch time and reporting any anomaly to the school authorities when he felt that he was in danger. He began to gain more confidence in himself every day and became proactive by becoming more aware of his surroundings.

Counseling treatment helped prevent Fernando from possible future psychological distress. With the help of counseling from Catholic Charities, Fernando was able to learn how to calm his nervousness and recuperate from the effects of the attack. He overcame his fears and regained his trust in people. Instead of becoming a statistic for suicide or a high school drop-out, Fernando graduated from his high school and will become the first member of his family to attend college.

#### **ELDER AFFAIRS & GUARDIANSHIP TRAINING**

#### Promoting Human Dignity for the Elderly

Where - Palm Beach County

**Description** — Comprehensive guardianship and case management services are provided to those in need, emphasizing the concerns of the economically disadvantaged and those without adequate community support. This multi-dimensional program protects elderly individuals from victimization, exploitation, abuse and neglect. Individuals who are 65 years and older, residing in Palm Beach County and who are at risk physically, mentally, emotionally, financially and/or spiritually are eligible.

Guardianship Training is a course of study approved by the Chief Judge of the Circuit Court and provided to guardians appointed in Palm Beach County to ensure that they understand their legal duties to both their ward and the court. Successful completion of this training course is required within four months after appointment as guardian.

Case Story – "Sam" was an 87 year old, living in his home in West Palm Beach in conditions that grew beyond his control. He is a diabetic and could no longer care for himself. He grew forgetful and confused. Elder Affairs' guardianship service provided assistance in selling his home, arranged for admission to a nursing care facility, and provides ongoing monitoring of his care. Now that he's eating a more nutritious diet and receiving medical care, his condition has stabilized and he is receiving the care he needs.

#### **HUNGER, HOMELESS AND OUTREACH**

#### Meeting the Needs of Our Community

Where – Pahokee and Riviera Beach

**Description** — The Hunger, Homeless & Outreach Program provides emergency services that assist individuals and families to attain economic stability and self-sufficiency through the provision of support services and appropriate referrals when necessary. The intent of emergency services is to address the presenting crisis, while at the same time, assessing and identifying the circumstances that led to the need for these services. Emergency support services include provisions of food, transportation and when available, assistance with rent and utility payments for those facing short term situational crisis. Referrals are made to other Catholic Charities programs as well as other social service organizations within the community service area. The Hunger, Homeless & Outreach Program also administers the Catholic Charities Angel Food "SNAC" Program providing nutritious weekend meals to 175 children throughout the Diocese.

Case Story — After fleeing from an abusive relationship to her homeland with her infant daughter, "Jane" discovered that because her daughter was an American citizen, she would not be entitled to an education and the prospects of a productive life would be limited. With her visa soon to expire, Jane decided to face her fears and come back to the United States. With resources running out and living in a motel, she contacted Catholic Charities for help. Through the Hunger, Homeless & Outreach Program, Jane was able to receive immediate assistance with food as well as a referral to local homeless program. She was also referred to Catholic Charities Immigration Legal Services and Birthline/Lifeline programs. Jane has since obtained permanent housing and has a well-paying job with another local nonprofit. Jane's visa has been extended and her daughter and she are doing very well.

#### **IMMIGRATION LEGAL SERVICES**

#### Keeping Families Together

Where - Pahokee, Riviera Beach, Stuart

**Description** – A multi-lingual, multi-cultural staff in three locations provides legal services to foreign-born individuals. The primary focus is to help with family reunification, re-entry permits, naturalization applications, labor and employment visas, fiancée visas and asylum applications.

Case Story — In August of 2013, a 50-year-old male from Honduras was granted U-visa status. The man, who has resided in the United States since 1989, was the victim of a violent armed robbery in West Palm Beach. He was thrown from a ladder, kicked and beaten while a gun was pointed to his head. He suffered multiple bruises, lacerations, and emotional trauma. The man provided valuable assistance to police which led to the suspects, who were arrested, charged, and convicted of Robbery with a Firearm. The man is now employed, authorized for a period of four years, and will be able to seek lawful permanent residence status in three years.

#### INTERFAITH HEALTH AND WELLNESS PROGRAM

#### Advocating for Health in our Community

Where - Riviera Beach, Pahokee and Fort Pierce

**Description**-Interfaith Health and Wellness is committed to the education of Registered Nurses who serve their congregations and communities by promoting holistic care of the body, mind and spirit. A Faith Community Nurse Basic Preparation course, offered annually in June, provides Registered Nurses the education and support to create health ministry programs in their respective congregations.

Case Story - Entensia, a Spanish speaking mother in her mid 40's, had been suffering from severe pain in her hips, knees and feet because she could not afford a follow up with medical treatment needed for her conditions and it was difficult with the language barrier. The Wellness Nurse helped her connect with health insurance that was able to cover her on-going treatment. She began attending the weekly Arthritis exercise class and Mother to Mother Health Ministry. Entensia now feels more comfortable with herself and confident in her ability to care for her family.

#### **PRISON MINISTRY**

#### Ministry of Presence

Where - Diocese of Palm Beach

**Description** - The most frequently asked question by prospective prison ministry volunteers and other inquiring minds is, "What exactly do you do?" The answer to this question varies depending on many factors, such as time allotted, space considerations, the availability of priests and deacons who are part of the volunteer cadre, and the makeup of the population being ministered to. It goes without saying that the Holy Sacrifice of the Mass, preceded by the Sacrament of Reconciliation, is the greatest gift the ministry brings to inmates, superseded only by the administration of the Sacrament of Baptism. Understanding that, and upon reflection, perhaps the best general answer to the question, "What exactly do you do?" is "We show up!"

It usually takes new volunteers a while before they come to understand that often it is not the agenda they planned, or the bible passage(s) selected for reading that will most impact the inmates on any given day; it will be nothing more than their presence. It is through consistent, faithful presence on the part of volunteers that inmates come to see for themselves true followers of Christ committed to living the gospel, and bringing His message of love, mercy and forgiveness to others they do not even know at some sacrifice to themselves. For many inmates, that kind of commitment doesn't go unnoticed and often is overpowering. Through the mere consistent, week-in and week-out presence of volunteers, the Holy Spirit reaches out and touches the hearts of those who are confined behind prison walls.

**Case Story** – Letter written to the volunteers of Prison Ministry from a thankful inmate:

I can't thank you enough for your service. I pray for you often and it brings me to tears sometimes when I think about how far reaching the tentacles of goodwill can go. You have a positive effect on me and then indirectly, my family and friends who I speak to daily and the other women I am incarcerated with. I am kinder and not violent with my thoughts or actions when I stay God-centered and in my bible (which you guys gave me). Angela, I love the saint of the day; I aspire to have a faith like them. Also, I am inquisitive by nature and I love learning the stories behind them. My God is right on time with His lessons and blessings, and my faith and patience are growing every day. I have been praying for the "Grey Panther" (a self-imposed nickname for Msgr. John McMahon, a priest who volunteers his time ministering in the prisons) and this retreat (Kairos men's retreat at Okeechobee Correctional Institution that Msgr. McMahon participates in) and I pray for these men to experience what I have, and will, experience by letting God into our lives and hearts. He's working in my life through all of you, through your patience with us and your dedication to come. None of you have ever made me feel judged or unworthy, I can believe you see me through God's eyes and it makes me feel so good that I try, vigilantly, to "pay-it-forward". This is an awesome domino effect! It will happen on a larger scale at this retreat. When I was praying that's when I started crying. I realized how many people were going to be positively effected by this and it's just great. To everyone involved and all of you for making it happen, thank you and God bless you. —C.

#### **RACHEL'S VINEYARD**

#### Healing the Pain of Abortion, One weekend at a Time

Where - Diocese of Palm Beach

**Short Description** – Rachel's Vineyard is a post-abortion healing program for both women and men. The ministry organizes retreats that enable men and women the opportunity to examine their abortion experience, identify the ways the loss has impacted each one in the past and present, and helps to acknowledge any unresolved feelings that many individuals struggle with after abortion. These retreats are a spiritual and emotional healing process and offer hope and healing to those suffering from post abortion trauma.

Case Story - I recently attended a Rachel's Vineyard; this is work and healing that I never wanted to do. It is still such a miracle to me that I actually did attend but such is God's grace! I thought it was too long ago. I thought it shouldn't matter anymore. I thought I was too old and that my life was over so why dredge up the ancient past. I thought so many things and they were all lies.

Thank you so much for having this ministry in our diocese! I am a returning Catholic, home for four years and away for forty years. I am so amazed at how wrong my perception of the Church was and amazed by the love and compassion I have found today.

I am so grateful to have had the opportunity to participate in Rachel's Vineyard and to hopefully pass on the blessings I have received. -D.

#### REFUGEE AND RESETTLEMENT

#### **Pursuing Freedom**

Where - Riviera Beach

**Description** – The purpose of the Refugee Resettlement Services is to help the newly arrived reach self-sufficiency as quickly as possible and assist them with social and economic adjustment to their new community. The program serves newly arrived refugees, asylees, Cuban/Haitian Entrants, as well as victims of Human Trafficking. All are foreign born clients seeking a better life away from oppression, violence, and lack of freedom. To be eligible for the program, refugees must be referred to the agency by the Department of State. However, Catholic Charities also serves asylees, Cuban/Haitian entrants and victims of Human Trafficking who hear about us from other agencies, border patrols, and national and international organizations.

Case Story — Maikel came to Catholic Charities in December 2012 in search of support as he started his new life in West Palm Beach. Maikel left his home in Villa Clara, Cuba in August 2012 as he was

granted a student scholarship to study Computer Science at the University Hasselt in Belgium and after his studies he was to return back to Cuba to continue his professional life there. The scholarship was supported by a collaborative program between the University of Villa Clara and Belgium. However due to the hardships in Cuba, he did not return and instead he made his way to Mexico in order to cross the border into the United States where he knew he would have freedom. He made his way to West Palm Beach to be welcomed by his cousin and sponsor who brought him to Catholic Charities. With the support of Catholic Charities and his own individual drive and energy he was able to start teaching job at South University at West Palm Beach due to his education and language skills. He is bilingual and has been a great example for his family and other refugees.

#### RESPECT LIFE

#### All Life is Precious

Where - Diocese of Palm Beach

**Description** – The Respect Life Ministry promotes life from natural conception until natural death through prayer, education, legislation and pastoral programs. It is concerned with the following issues: Abortion, Physician Assisted Suicide/Euthanasia, Death Penalty, End of Life, and Bioethics.

Case Story – Youths Enforce Respect for Life

Life Force was organized in 2011 as a youth led ministry whose mission statement best describes the ministry's purpose:



Respect Life Youth

"A teen ministry standing up for life". This Catholic Charities Respect Life teen ministry is dedicated to promoting respect for life through organized events and programs throughout the diocese. Life Force's inaugural event promoting the pro-life message took place in October of 2011 at Saint Ignatius Cathedral Loyola and was attended by over 300 youth. This event titled "Celebrate a Day of Life" included prayer, pizza dinner, Mass and a concert by recording artist Tony Melendez. This event is held during Respect Life Weekend (the first weekend in October) and was successfully repeated in 2012. The youth involved in this ministry are dedicated to respecting life and make it their mission to live out these words spoken by Pope John Paul II "We will stand up for life whenever it is threatened and this is the mission and duty of the universal Church: to defend the defenseless."



#### **SAMARITAN CENTER**

20 years: Bridging the Gap for Homeless Families

Where - Vero Beach

**Description** – This long-term transitional residential facility for homeless families in Indian River County features a structured step-based program with onsite case managers that help pregnant women and homeless families develop the life skills needed for successful reintegration into mainstream society.

Case Story – Samaritan Center celebrated its 20th anniversary during the 2012 – 2013 fiscal year. The program has celebrated many successes over the

years but this year was especially wonderful because two clients graduated out of the program and into Habitat for Humanity homes! For these two families specifically, Samaritan Center's long term, structured program was the best option available and allowed them to gain self-sufficiency and end their cycle of homelessness. The lives of these two families, along with other 88 unduplicated clients served this year, is forever changed because of the opportunity given to them at Samaritan Center.

## 2nd Annual Caritas Dei Bishop's Gala Raises Over \$368,000











Over 250 friends, donors, sponsors and guests attended Catholic Charities' 2nd Annual Caritas Dei Bishop's Gala on Sunday, February 10, 2013 at The Breakers Hotel in Palm Beach. This year's event raised over \$366,000 to help provide direct services to the 9,000 unduplicated clients that are served each year by the 14 programs and ministries of Catholic Charities. The annual gala is the agency's main fundraiser and provides much needed financial support to the programs and ministries that fall short on funding.

Guests were greeted by Most Reverend Gerald M. Barbarito, Bishop of Palm Beach, as they entered the cocktail hour. The silent auction included more than 230 items and filled an entire ballroom. The auction included pieces of art donated by Wally Findlay Galleries, Collection Handbags from both Daniella Ortiz and the Michael Kors Worth Avenue Boutique, a Tour of the Florida Capitol sponsored by Senator Maria Sachs and many beautiful orchids.

A live auction was conducted during dinner by Neil Saffer, Professional Auctioneer. Saffer ended the auction with a call to the heart to raise money for Catholic Charities' Hunger, Homeless and Outreach Program. Generous donor bids raised more than \$57,000 for the program's Angel Food SNAC backpack initiative which will fill children's backpacks Fridays with food to supplement their meals over the weekend.




